



the building of houses, dwellings or chawls or by grants of money, pensions, allowances, gratuities, bonuses or other payments or by creating and from time to time subscribing or contributing to provident and other funds, institutions and trusts and by providing or subscribing or contributing towards places of instruction and recreation, hospitals and dispensaries, medical and other attendance and assistance as the company shall think fit.



13. 



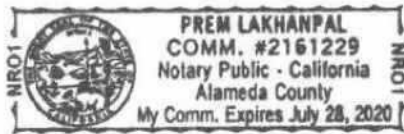
